Pursuant to Article 19, Paragraph 3 of the *Regulation (EU) No. 596/2014 on market abuse*, Atlantic Grupa d.d., Zagreb, Miramarska 23 (hereinafter referred to as: the Issuer), hereby sends out the notification on the release of 500 shares of the Issuer, with the total nominal value of HRK 20,000.00, identification code ATGR-R-A: ISIN: HRATGRRRA0003, by Neven Vranković, Member of the Management Board of the Issuer. The mentioned shares represent 0.01% of the subscribed capital of the Company, i.e. 0.01% of the votes at the General Assembly of the Company.

Before the stated release, the Member of the Management Board Neven Vranković held 20,024 shares of Atlantic Grupa d.d., with the total nominal value of HRK 800,960.00, which represent 0.6% of the subscribed capital of the Company, i.e. give 0.6% of the votes at the General Assembly of the Company. After the stated release, the Member of the Management Board Neven Vranković holds 19,524 shares of Atlantic Grupa d.d., with the total nominal value of HRK 780,960.00, which represent 0.59% of the subscribed capital of the Company, i.e. give 0.59% of the votes at the General Assembly of the Company.

Also, pursuant to Article 19 of the *Regulation (EU) No. 596/2014 on market abuse*, the Issuer hereby notifies on the release of 500 shares of the Issuer, with the total nominal value of HRK 20,000.00, identification code ATGR-R-A: ISIN: HRATGRRRA0003, by Mladen Veber, Member of the Management Board of the Issuer. The mentioned shares represent 0.01% of the subscribed capital of the Company, i.e. 0.01% of the votes at the General Assembly of the Company.

Before the stated release, the Member of the Management Board Mladen Veber held 14,306 shares of Atlantic Grupa d.d., with the total nominal value of HRK 572,240.00, which represent 0.43% of the subscribed capital of the Company, i.e. give 0.43% of the votes at the General Assembly of the Company. After the stated release, the Member of the Management Board Mladen Veber holds 13,806 shares of Atlantic Grupa d.d., with the total nominal value of HRK 552,240.00, which represent 0.41% of the subscribed capital of the Company, i.e. give 0.41% of the votes at the General Assembly of the Company.
